# JWCE's Monster Fish Cleaning Station Helps Lake Cachuma

Nestled in quiet Santa Barbara County sits Cachuma Lake Recreation Area - a shining blue lake, county park and recreation area on over 6,000 acres. Sheltered by the Santa Ynez and San Rafael mountains, Cachuma Lake is a virtual one-stop recreation area, with a boat launch, picnic areas, playgrounds, camp sites, hiking, aquatic center and fishing.

Stocked annually with large and small mouth bass, crappie, bluegill, sunfish, catfish, and rainbow trout, Cachuma quickly became a favorite fishing and recreation destination and by 1980 had registered over 1 million visitors. Lake Cachuma hosts annual fishing derbies and is viewed by fishermen as one of the most heavily stocked lakes in Southern California.

With the increase in fishermen came a serious facility problem - the original fish cleaning area began to wear down. In early 2000 the U.S. Bureau of Reclamation worked on a project to modernize and update the fish cleaning station. According to Daniel Hernandez, Director, Santa Barbara Parks Department, "We needed to replace the old cleaning station, which was an old wooden table with a box."

A Monster Fish Cleaning Station by JWC Environmental of Costa Mesa, California was selected and installed in July 2008. "The Monster Fish Cleaning Station was easy to clean and maintain," said Hernandez. The Monster Fish Cleaning Station is an excellent way to provide a pleasant park experience for residents and visitors.
